**SUBJECT: POSTINGS FOR THE POST OF EXECUTIVES (ON ENGAGEMENT FROM  
DEPARTMENT OF POSTS) FOR VACANT LOCATIONS  
DECLARED VIDE NOTIFICATION DTD 11.11.2022**

1. The posting orders of the selected candidates for the post of Executives on engagement from DoP against 650 vacancies was published on the Bank's website on 26/07/2022. These candidates were requested to report at their respective allotted branches on or before 31<sup>st</sup> August 2022 vide Corrigendum III dated 20<sup>th</sup> August 2022.
2. Considering the vacant locations, two waiting lists have been drawn for circles with surplus qualified candidates. The 04 circles namely Assam, North East, Uttar Pradesh, West Bengal were not considered for these waiting lists as they did not have any surplus qualified candidates.
3. Applications for the vacant locations in 04 circles namely Assam, North East, Uttar Pradesh and West Bengal were invited from the remaining pool of qualified candidates after excluding those who were shortlisted for merit-based list, Waiting List (01) and Waiting List (02) vide our notification dated 11.11.2022.
4. Applications received till 25.11.2022 were scrutinized and postings finalized have been furnished in Annexure-I.
5. In cases where more than one request was received for any location, postings were decided based on the merit of marks obtained in the written exam. It may be noted that candidates who didn't join, due to any reasons, from the posting orders published on the Bank's official website on 28<sup>th</sup> July 2022, Waiting List (01) and Waiting List (02) were not considered under this provision.
6. Based on the annexed posting orders, the candidates are requested to report at their respective allotted branches on or before 15<sup>th</sup> December 2022 along with all the necessary documentation as enumerated under <https://www.ippbonline.com/web/ippb/current-openings/Advertisement for Engagement of Grameen Dak Sevaks to IPPB/ Joining Formalities Required for GDS Selected as Executives to IPPB>.
7. Actual appointment is subject to verification of the eligibility criteria and vigilance clearance from the parent organization. Further, the appointment of the candidates is provisional and subject to the submission of the documentary evidence of their employment with the parent organization.
8. The candidate shall be disqualified, if found ineligible, at any stage.
9. Utmost care has been taken while compiling the selection of annexed list of candidates. However, the Bank reserves the right to rectify inadvertent errors found subsequently, if any.
