Subject: Postings for Executives (on engagement from DoP) for vacant locations across 18 circles from pool of circle-wise qualified candidates

1. The Bank invited applications for vacant locations across 18 circles from pool of circle-wise candidates for the post of Executive (on engagement from DoP) vide notification dated 15th December 2022 published on the Bank's website. The last date to apply for the same under this provision was 25th December 2022.
2. With a view to garner larger pool of applications and to provide extended opportunity to the circle-wise qualified candidates to apply under this provision for various locations across 18 circles, the last date of the same was extended till 06th January 2023.
3. The received applications under this provision were scrutinized on the basis of various parameters like marks obtained in the written examination and weeding out the multiple applications by a single candidate and applications received from previously selected candidates in merit list, waiting lists (WL-01) & (WL-02) and posting orders across 04 circles. After this detailed scrutiny, 46 candidates have been selected and their posting orders of these 46 candidates are furnished as **Annexure-I**.
4. Based on annexed posting orders, the candidates are requested to report at their respective allotted branches on or before 31st January 2023 along with all the necessary documentation as enumerated under [https://www.ippbonline.com/web/ippb/current-openings/Advertisement for Engagement of Grameen Dak Sevaks to IPPB/Joining Formalities for GDS selected as Executives on engagement](https://www.ippbonline.com/web/ippb/current-openings/Advertisement%20for%20Engagement%20of%20Grameen%20Dak%20Sevaks%20to%20IPPB/Joining%20Formalities%20for%20GDS%20selected%20as%20Executives%20on%20engagement).
5. Actual appointment is subject to verification of the eligibility criteria and vigilance clearance from the parent organization.
6. The appointment of the candidates is provisional and subject to the submission of the documentary evidence of their employment with the parent organization.
7. The candidate shall be disqualified, if found ineligible, at any stage.
8. The selection/ posting is made based on the preference branch provided by the candidate.
9. Utmost care has been taken while compiling the selection of the below list of candidates. However, the Bank reserves the right to rectify inadvertent errors found subsequently, if any.
